- 2) 申請人必須於網上遞交報名表格及通過指定方法繳交色弱及體能檢測費用，並上載繳費紀錄或收據，檢測行政費用一經繳交，概不發還。
The applicant should submit the application form online and use the designated electronic payment for the administrative fee for the tests. The fee will not be refunded once it is paid.

男子：14 分鐘平地跑，最少完成 2,000 米；及 1 次 40 米短跑，6.8 秒或以下
女子：16 分鐘平地跑，最少完成 2,000 米，及 1 次 40 米短跑，7.0 秒或以下

Applicant should fulfill the requirements of the Color Blindness Test and fitness check. Please see the timetable of fitness check. The timeslots for participants of the fitness check are assigned by the Referees Department. Color Blindness Test sample can be found in the application form.

Fitness Check Requirements:

For men: Run at least 2,000m in 14 mins, and 1 40m sprint within 6.8 sec

For women: Run at least 2,000m in 16 mins, and 1 40m sprint within 7.0 sec

考試須知 **About Examination**

- 1) 課程總成績將根據學員課堂表現、操守紀律及筆試三方面作出評核。學員必須於上述三方面取得合格成績方才評為“合格”，其中學員之筆試成績必須不少於考試卷總分之 70%。

The participant will be assessed on three aspects, the written examination, performance in the class and practical trainings, as well as the conduct. Participants will be rated as pass only when the requirements in these aspects can be met. The passing mark of the written examination should be 70% or above of the total mark of the paper.

- 2) 課程合格並通過場地考核者將可於香港足球總會註冊為“新裁判員”。

For participant obtaining pass for the course and the field assessment, he/she can register as “New Referee” of the HKFA.

- 3) 所有學員必須出席最少 90% 之課堂〔即最多缺席 1 堂〕，否則將被取消參加筆試的資格。

If participant’s attendance is less than 90%, the participant cannot take part in the written examination.

- 4) 若學員未能出席 2024 年 9 月 3 日舉行的筆試，將不會獲得補考的資格。

Participant must sit in the written examination on 3 September 2024; otherwise, the participant cannot sit in the re-test.

- 5) 本課程之補考日期為 2024 年 9 月 19 日，而每名學員只有一次補考機會。

The re-test is scheduled on 19 September 2024. Applicant can take the re-test once only if they meet the re-test requirements.

- 6) 學員必須通過以下條件才能獲得補考機會：

Following requirements must be fulfilled by the participant for the re-test:

- i) 學員之筆試成績必須不少於試卷總分之 60%

The score of written examination should be higher than 60% of the paper.

- ii) 課堂表現良好

Good performance in the class.

- iii) 整體操守表現良好

Good conduct.
