《 評 選 方 法 》

以下為中國香港足球總會 D 級教練課程[D-80 女子教練]審核參加者入選資格的評選方法：

本會將會以加分制評選合資格的學員，分數較高者將會被優先取錄。

以下為加分制的形式：

第一類別：現代表或曾代表香港女子足球代表隊之人士

現代表或曾代表香港女子足球代表隊
10 分

第二類別：現代表或曾代表香港女子青少年足球代表隊

現代表或曾代表香港女子青少年足球代表隊
5 分

第三類別：三年內具本地女子足球比賽經驗人士(截至 2025-26 年賽季)

女子甲組聯賽	女子乙組聯賽	女子丙組聯賽
5 分	3 分	2 分

參加者若同時擁有第三類別內多項資格時，本會則選取較高分者

範例：若參加者現正代表香港女子足球代表隊及曾代表香港女子青少年足球代表隊，並在過去三年內為本地女子甲組及乙組足球聯賽的註冊球員。

參加者將獲得：10+5+5=20 分

備註：

1. 持有較高分數的申請人會被選為是次課程的參加者。
2. 在每一個範疇中，本部只計算申請者在該範疇中得分最高的一個項目。
3. 本會將保留一切有關於本次評選活動之決定權，本次評選機制將會以中國香港足球總會的決定為準。



HKFA D Coaching Certificate Course [D-80 Female Coaches]

«Selection Criteria»

Here are the selection criteria for enrollment into HKFA “D” Coaching Certificate Course [D-80 Female Coaches].

Details are as follows:

The association will use an accumulate system to select qualified students, and those with higher points will be given priority for admission.

The format of the accumulate system:

Category A: Former/ Current Hong Kong Women Representative Team Players

Former/ Current Hong Kong Women Representative Team Players
10 points

Category B: Former/ Current Hong Kong Youth Representative Team Players

Former/ Current Hong Kong Youth Representative Team Players
5 points

Category C: Individuals with local women's football league experience within the past three years (up to the 2025-26 season).

Women's football Division 1	Women's football Division 2	Women's football Division 3
5 points	3 points	2 points

If an applicant has more than one experience above, HKFA will enroll applicants with the highest points

Example: If a participant currently represents the Hong Kong Women's Representative Football Team and has previously represented the Hong Kong Youth Representative Football Team, and has been a registered player in the local Women's First and Second Division Football Leagues within the past three years,

The participant will receive: $10 + 5 + 5 = 20$ points.

Remarks:

- 1. Applicants with the highest score will be selected.**
- 2. For each category, only the highest point item the applicant possesses will count.**
- 3. The association reserves all rights to make decisions regarding this selection process.**
